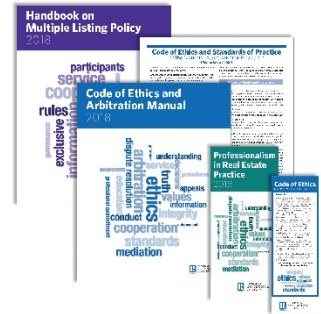




## FACT SHEET 2018 CODE OF ETHICS AND MEMBER POLICY PRODUCTS
