

COMMERCIAL GOVERNANCE MEETINGS SUMMARY

The Commercial Economic Issues & Trends Forum

featured Lawrence Yun, NAR Chief Economist and Mark Vitner, Senior Economist with Wells Fargo Securities. The economic updates focused on the slow growth in GDP, as well as the global impact upon U.S. economic activity—especially China and the European Union. Yun and Vitner both underscored the solid and improving fundamentals and investment sales, while cautioning about the outlook for prices, especially at the upper end of the market. Yun also shared the results of the NAR *Commercial Real Estate Lending Trends 2016* report, which showed a tightening in bank lending conditions for commercial projects, mostly due to increased regulatory burdens and scrutiny.

Commercial Leadership Forum had a packed agenda - showcasing new education on the topic of sustainability & leasing, as well as new courses from CCIM Institute, now being offered with a REALTOR® discount. Xceligent presented an overview of their national expansion and the addition of their latest tool, PropertyTourPro. Attendees heard from a panel of local leaders & staff on ways to better engage commercial practitioners, an overview of NAR programs related to Smart Growth and community development and a discussion on how members can take advantage of international business opportunities.

The Property Management Forum brought together a panel of experts from the Department of Energy, the Environmental Protection Agency and the Institute for Market Transformation to discuss the environmental and green mandates that are currently in effect or on the horizon impacting property managers and what they need to know to stay in compliance. An introduction to the NAR REach® Program was made by highlighting an exciting new venture, Trust Stamp, an id verification app that can add another layer of security when working with clients or tenants.

During the Commercial Legislation & Regulatory Advisory Board, Evan Liddiard, NAR Senior Tax Policy Representative gave a presentation on federal issue affecting commercial real estate tax provisions including taxing extender (179D), 1031 Like-Kind Exchanges and depreciation. A highlight of the meeting was guest speaker Grant Wilson, Director of Commercial Credit Risk in the Commercial Credit Policy office of the OCC. Grant provided data on how much money banks are lending to commercial real estate, how much financing is provided by banks, as well as areas that have seen growth in recent years.

COMMERCIAL GOVERNANCE MEETINGS SUMMARY CONTINUED

At the Commercial Real Estate Research Advisory Board, NAR's Research staff provided a presentation on the trends in REALTOR® commercial lending markets and the results of the 2016 NAR Commercial Lending survey. Members and guests engaged in a discussion about issues surrounding bank underwriting, particularly in regards to upcoming CMBS maturing debt. Michael Griffin, President and CEO of ClientLook provided a presentation of the company's customer relationship management (CRM) system, now an integrated option with REALTORS® Property Resource (RPR).

The Commercial Committee navigated a full agenda including guest speaker Felix Carles, the Panamanian bilateral partner's Liaison with NAR, who gave a presentation on the development of the Panama Canal and the impact on the local economy and commercial real estate development opportunities forthcoming in this area of the world. Members were updated on NAR's increased presence at MIPIM, one of the largest commercial property events in the world. NAR hosts the United States pavilion, providing greater visibility for properties and commercial brokers on a world stage. Committee members also heard a presentation on the preliminary direction of the commercial consumer advertising campaign currently in development, an Xceligent update on property research in markets around the country and the rollout of the all-new CommercialSearch.com listings website.




