

2024 C2EX Ambassador Challenge

Terms & Conditions

Challenge Timeline

- **July 10** – 2024 C2EX Ambassador Challenge (“Challenge”) launches.
- **July 10 to Oct. 1** (“Challenge Period”) – During this Challenge Period, each state, local or territorial REALTOR® Association (“Association”) with at least one (1) existing or nominated C2EX Ambassador during the challenge period will be automatically entered into a drawing to win a \$500 C2EX Grant. C2EX Ambassador is defined as a C2EX Endorsed member of NAR selected by the C2EX committee and/or nominated by an Association to attend C2EX Ambassador training, annually deliver 4 or more C2EX presentations annually, either virtually or in person, and fulfill all requirements of a C2EX Ambassador.
- **Oct. 1** – Deadline for an Association to nominate a C2EX Ambassador.
- **Oct. 1 at midnight (CT)** – 2024 C2EX Ambassador Challenge closes.
- **Oct. 2** – Eight (8) Associations will be selected in a drawing (“Challenge Winners”). Challenge Winners will be notified on or before October 15, 2024.
- **2024 NAR NXT** – At the 2024 NAR NXT, the Challenge Winners will be announced and each is awarded a C2EX Grant of five hundred dollars (\$500) that the Challenge Winner can use to purchase materials such as a pull-up banners, promotional items, and C2EX Endorsement pins to promote the C2EX Program to their members.

2024 C2EX Ambassador Challenge Rules

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED BY LAW.

The eight (8) Challenge Winners will be honored at 2024 NAR’s NXT, (“Conference”). Every Challenge Winner is encouraged to be present during the Conference.

During this Challenge Period, each Association with at least one (1) existing C2EX Ambassador will be automatically entered into a drawing to win a C2EX Challenge Grant. An Association may opt out of the Challenge by providing written notice to NAR Staff at C2EX@nar.realtor within the Challenge Period.

To be eligible for the Challenge Winner drawing, an Association must meet the following requirements within the Challenge Period:

- The Association must be located in the United States, Puerto Rico, U.S. Virgin Islands, Guam or the District of Columbia;
- The Association must have at least one (1) existing ambassador or nominate a C2EX-endorsed member to serve as a C2EX Ambassador during the challenge period to be entered in the Challenge. Each Association will receive one (1) entry in the drawing to win a C2EX Challenge Grant for each existing or nominated C2EX Ambassador holding primary membership with the Association.
- The C2EX Ambassador Application and nomination form, available at <https://c2examb.apps.realtor/>, must be completed, submitted and approved by staff of the National Association of REALTORS® (“NAR”).

Each Challenge Winner will be awarded a C2EX Grant (“Prize”) that will consist of: (i) an announcement of the Challenge Winner’s selection at the 2024 NAR Annual Conference; and (ii) a grant of five hundred dollars (\$500) that the Challenge Winner must use to promote the C2EX program to their members, including but not limited to purchasing promotional materials and items, banners, posters, flyers, advertising, promotional campaign and C2EX Endorsement pins. The Prize is non-transferable and non-assignable and subject to applicable laws and regulations. Any attempt to transfer or assign the Prize will be void. Any taxes imposed upon a Prize will be the sole responsibility of the Challenge Winner.

The Challenge Winners will be randomly drawn by a designated representative(s) of the C2EX Committee.

The 2024 C2EX Ambassador Challenge and its terms and conditions are governed by the laws of the State of Illinois. If any portion of the Challenge or the terms and conditions are deterred by any court or governmental agency of competent jurisdiction to violate applicable law or otherwise not conform to requirements of law, then the rest of the Challenge and/or its terms and conditions will remain in effect and NAR may substitute a suitable and equitable provision for the invalid/unenforceable provision in order to carry out the original intent and purpose of the Challenge and/or its terms and conditions.

The staff of NAR and the program sponsors will not take phone calls or release any information regarding the winner determination process, or status of the entries.

Except where prohibited by law, Challenge Winners, through their representatives, agree and consent: (i) to be interviewed, photographed, filmed, taped, and/or interviewed NAR and/or featured in NAR promotions, in NAR’s sole discretion; (ii) to allow NAR to use the Challenge Winner and its managing brokers and agents’ names, voices, pictures, likeness and biographical data and or any other information contained in the C2EX Ambassador Nomination form without additional compensation. In connection therewith, all Challenge Winners grant full permission and consent to NAR to using any of the results of such photographing filming, taping and/or interviewing in any and all media now known or hereafter devised and hereby release NAR from all liability related thereto.

NAR, and the C2EX Committee are not responsible for late, stolen, technical problems, or misdirected applications.

If there is insufficient participation in the Challenge, NAR may, in its sole and reasonable discretion, decide to cancel the Challenge.

All information submitted by Challenge participants must be true and correct at all times, and are responsible for keeping such information up-to-date.

At any time, in the sole and absolute discretion of NAR, it will be entitled to disqualify a Challenge participant and/or not allow the Association's CEO, AE, or Education Director or (s) to be counted towards the Challenge requirements in the event of a failure to meet relevant criteria or any other violation or suspected violation of these Terms and Conditions.

By participating in the Challenge, the Association must release NAR from any and against any and all injury, loss or damage caused or claimed to be caused by its participation in the 2024 Ambassador Challenge and/or the acceptance, awarding, receipt, use and/or misuse of the Prize. By participating, each Association agrees that: (a) any and all disputes, claims, and causes of action arising out of or in connection with the 2024 C2EX Ambassador Challenge, or any prizes awarded, must be resolved individually without resort to any form of class action; (b) any claims, judgments and awards will be limited to actual out-of-pocket costs incurred, including costs associated with entering the 2024 C2EX Ambassador Challenge, but in no event attorney's fees; and (c) under no circumstances will any entrant be permitted to obtain any award for, and entrant hereby waives all rights to claim, punitive, incidental or consequential damages and any and all rights to have damages multiplied or otherwise increased and any other damages, other than damages for actual out-of-pocket expenses.
