

National Association of REALTORS® Riding with the Brand Sweepstakes

OFFICIAL RULES

To be eligible to win a prize in the Riding with the Brand Sweepstakes, please follow these rules:


- 1. Entry Period:** Riding with the Brand Sweepstakes (“Sweepstakes”) begins at 12:01 a.m. CT on August 7, 2022 and ends at 5:00 p.m. PST on November 15, 2023 (“Entry Period”).
- 2. Eligibility:** You must be a member in good standing of the National Association of REALTORS® (“NAR”) with valid REALTORS® M1 identification or a staff person from a national, state, or local REALTOR® association or an NAR Institute, Society, or Council who has a REALTORS® M1 identification number, who are legal residents of the fifty (50) United States, District of Columbia, or U.S. Territories, and who are 18 years of age or older at time of entry and drawing(s). Members of the 2023 NAR Leadership Team and employees of National Association of REALTORS® (***who are involved with the administration of the Sweepstakes***), including their immediate families (parents, spouses, children, siblings and each of their parents, spouses, children and siblings) and household members (whether or not related), are not eligible to enter the Sweepstakes. This Sweepstakes is not open to the general public.
- 3. How to Enter:**
 - a. Donation Entry: You may enter this Sweepstakes by donating a minimum of \$50 to the REALTOR® Relief Foundation (RRF) by successfully scanning an official Sweepstakes QR Code, texting RWTB to the number 41444 or via www.nar.realtor/riding. Although it is free to enter, if you enter using a mobile device, message and data charges may be incurred. You are responsible for any fees associated with internet access, device usage charges, or any other charges incurred in connection with your entry. Limit of three (3) separate Donation Entries per person.
 - b. Alternate Means of Entry: You may enter this Sweepstakes by sending an email to rwtbsweepstakes@nar.realtor as indicated herein. The email must contain all and only the following

information: Subject Line: **“My Entry for the Riding with the Brand Sweepstakes”**, your REALTORS® M1 number, name of your associations, your full name, street address, telephone number, and email address. Limit of three (3) separate Alternate Means of Entries per person.

4. No responsibility is assumed for the lost, late, incomplete, or ineligible entries. Late entries will not be eligible.
5. **NO DONATION NECESSARY TO ENTER OR WIN. DONATION DOES NOT INCREASE YOUR ODDS OF WINNING.** Void where prohibited by law.
6. **Drawings/Odds of Winning:** The Sweepstakes will consist of at least one (1) random drawing for one (1) prize of a 2022 Harley Davidson FLTRX (approximate value: \$35,000). NAR, in its sole discretion, may elect to hold multiple random drawings for additional prizes of greater, equal, or lesser value. In such an event, NAR will notify all eligible entrants and prior submitted entries, including details about the prize (i.e., type, value, etc.). The drawing(s) will be held on or about November 16, 2023. Each entrant is eligible to win the prize in this Sweepstakes. Prize(s) are non-transferable, no substitution of the prize will be permitted, except that NAR reserves the right, in its sole discretion, to substitute the prize with a prize of equal or greater value in the event prize becomes unavailable for any reason. Chances of winning depend on the number of eligible entries received. In no event will NAR be obligated to award more than the one prize, as indicated herein.
7. **Restrictions on Prize:** Winners will be notified in-person, by phone, or e-mail. Winners may be asked to provide their REALTORS® M1 number, which will be used to confirm their eligibility status in NAR’s membership database or required to sign and return an affidavit of eligibility, a liability release, and, where lawful, a publicity release within twenty-four (24) hours of notification. In the event, NAR cannot confirm the eligibility of the winner, a requested affidavit and/or release is not signed and returned within twenty-four (24) hours, or if the prize notification is returned to NAR as undeliverable, then an alternative eligible winner will be selected. If the winner resides within the contiguous forty-eight (48) United States or District of Columbia, the prize will be awarded and delivered by NAR following the drawing. If the winner resides within Alaska, Hawaii, or a US Territory, NAR will provide winner a \$1,000 transportation credit and

winner will be responsible for all other costs and arrangements to move the prize to its desired location.

- 8. Liability Release:** Winners, by accepting the prize, agree that the prize is awarded on the condition that NAR and its agents, officers, directors, representatives, and employees will have no liability whatsoever for any injuries, losses, or damages of any kind resulting from the acceptance, possession, misuse, or use of the prize or participation in the Sweepstakes. Winner further acknowledges that NAR has not made nor is in any manner responsible or liable for the warranty, representation, or guarantee, express or implied, in fact or law, relative to the prize including but not limited to, its quality, mechanical condition, or fitness. All entries submitted become the property of NAR (*except donation entries become the property of RRF*) and will not be acknowledged or returned. By participating, entrants agree to these official rules, and that the decision of the judges is final and binding in all matters relating to the Sweepstakes. Any taxes imposed upon a prize will be the sole responsibility of the winner. License, registration fees, insurance, applicable tax, maintenance, repairs, operating expenses, and additional options and any expenses not specified of the prize are the sole responsibility of the winner.
- 9. Consent:** Entrants consent to being contacted by NAR by phone, including text message, for anything related to this Sweepstakes. Winners, where lawful, grant permission for the use of winner's name, voice, city, state and photograph or videotape for advertising and promotional purposes in conjunction with this and similar promotions without additional compensation.
- 10. Early Termination of Sweepstakes:** If, for any reason, the Sweepstakes is not capable of running as planned, including but not limited to tampering, unauthorized intervention, or fraud beyond the control of NAR, which corrupts or affects the administration, fairness, integrity or proper conduct of this Sweepstakes, NAR reserves the right in its sole discretion to cancel, terminate, modify or suspend the Sweepstakes. NAR is not responsible for misdelivered or delayed entries, lost, miscommunications, or other error of any kind. Persons found tampering with or abusing any aspect of this Sweepstakes, as solely determined by NAR, will be disqualified. Any attempt to damage or tamper with or undermine the legitimate operation of the Sweepstakes, is a violation of these Official Rules.
